1. Introduction

These parties are required to keep your information confidential and handle it in accordance with applicable privacy laws.

We will **not sell your personal information** to unrelated third parties.

6. Overseas Disclosure

Some of our service providers or partners may be located overseas. Where this occurs, we will take reasonable steps to ensure that your personal information is handled in accordance with Australian privacy law.

7. Data Security

We take reasonable precautions to protect your personal information from misuse, interference, loss, unauthorised access, modification, or disclosure.

Personal information is stored securely, whether in electronic or hard copy form.

8. Access and Correction

You may request access to the personal information we hold about you, or request corrections if you believe it is inaccurate, incomplete, or out of date. We will respond within a reasonable timeframe and in accordance with the APPs.

9. Complaints

If you have concerns about how we handle your personal information, you may contact us (see Section 11 below). We will investigate your complaint and respond in writing within a reasonable timeframe.
